Q. What are my chances to receive a CE scholarship?

The goal is to award a scholarship to all who take the time to submit an essay; however, the quality must be acceptable (neatness, spelling, grammar).

Since 2001, nine ophthalmic medical personnel have been honored with the Virginia Boyce award for their volunteer service to improve the quality of eye care.

Virginia S. Boyce passed away in July 2009 at the age of 96. Virginia served as JCAHPO's public advisor from 1982-92,

and chair of the Foundation from 1990-2000.

Mrs. Boyce retired from public service after 45 years with the National Society to Prevent Blindness (now Prevent Blindness America) organizing, teaching, and advancing preventative eye health care throughout the world.
